**Minutes**

McCoy/Leavitt to approve the minutes of the June 9, 2015, meeting. Motion carried by voice vote.

**Mayoral Appointments** Babcock/McCoy to approve the Mayor's appointment of Steve Grzenia to the Board of Park Commissioners. Motion carried by voice vote.

**City Administrator Report**

**Petition for Direct Legislation** Thiel presented the certified petition. Mr. William Waser of Reedsburg spoke on behalf of the Move to Amend group. He briefly explained the reasoning behind the petition.

**Resolution 2015-11 Resolution Supporting the Move to Amend Campaign's Proposed 28th United States Constitutional Amendment** McCoy/Nielsen to adopt Resolution 2015-11. Motion carried unanimously by roll call vote.
