**ANNUAL TOWN AND
TOWN SCHOOL DISTRICT MEETING
March 6, 2012**

The legal voters of the Town of Brattleboro and the Town School District of Brattleboro, are hereby notified and warned to meet at the polling places designated for the three districts in said Brattleboro, on Tuesday, the sixth day of March, 2012, to act on the following articles:

ARTICLE 1: To choose all Town officers, Town School District members and Brattleboro Union High School District directors required by law to be elected at the annual meeting. Also to be elected under this Article are Town Meeting members from the following districts: District #1: 15 members for three year terms and 3 members for two year terms; District #2: 14 members for three year terms and 6 members for two year terms and 3 members for a one year term; District #3: 14 members for three year terms and 2 members for two year terms. Voting on this Article is to be done by Australian ballot.

ARTICLE 2: Shall the voters vote to approve the following resolution: Whereas, government of, by, and for the people has long been a cherished American value, and the people's fundamental and inalienable right to self-govern, and thereby secure rights to life, liberty, property, and the pursuit of happiness is guaranteed in the US Constitution; and, Whereas, free and fair elections are essential to democracy and effective self-governance; and, Whereas, the recent Citizens United v. the Federal Election Commission Supreme Court decision allows unlimited corporate spending to influence elections, candidate selection, policy decisions and votes. Therefore, be it resolved, that the voters of the Town of Brattleboro call on our representatives in Congress, Senator Patrick Leahy, Senator Bernard Sanders and Representative Peter Welch to initiate and support such legislative action as may be appropriate to regulate corporate spending on political campaigns; and, Be it further resolved, that the voters of the Town of Brattleboro directs the Town Clerk to send copies of this Resolution to the President of the United States, our Congressional representatives, our Vermont legislative representatives, and all local media outlets; and to arrange that a copy of this Resolution be placed on the Brattleboro Town website. Pursuant to Town Charter, Article III, Section 2, this Article is advisory only and shall be acted upon by all voters of the Town by Australian ballot.

For the above purposes, the polls will open at 9:00am and close at 7:00pm. The polling place will be as follows:

Districts #1, #2 and #3 at Brattleboro Union High School, Gymnasium, Fairground Road.

**ANNUAL REPRESENTATIVE TOWN MEETING
March 24, 2012**

The legal voters qualified to vote in Representative Town Meeting are hereby notified and warned to meet in the gymnasium of the Brattleboro Union High School on Saturday, the twenty-fourth day of March, 2012, at 8:30am, to act on the following Articles:

ARTICLE 1: To act on the Auditors' reports (Town and Town School).

ARTICLE 2: To elect three trustees for the Brooks Memorial Library to serve three years and two trustees for the Brooks Memorial Library to fill unexpired terms of one year. The names for consideration are: Three year terms (2012 – 2015): Kenneth Vitale, Adam Franklin-Lyons and Thomas P. Murray; Unexpired terms (2012 – 2013): Pam Becker and Jane Southworth.

ARTICLE 3: To elect two representatives to the Capital Grant Review Board for a term of one year from March 24, 2012. (Two members will be nominated from the floor.)

ARTICLE 4: To see if the Town and Town School District will authorize its Selectboard and School Directors to employ a certified public accountant or public accountants.

ARTICLE 5: To see if the Town will ratify, approve and confirm the Selectboard's appointment of a Town and Town School District Clerk for a term of one year.
