

Jane Gray moved Article #12, Peter Klose seconded. There being no discussion, Article #12 was declared passed by hand vote.

ARTICLE #13

To see if the Town will vote to raise and appropriate the sum of \$358 to assist The Mental Health Center.

Agreeable to a petition signed by Suzanne Raiche and others.
Recommended by the Board of Selectmen.

Barbara Holmes moved Article #13, Bob Bridgham seconded. There being no discussion, Article #13 was declared passed by hand vote.

ARTICLE #14

To see if the Town will vote to raise and appropriate the sum of \$300 for the Eastern Slope Airport Authority for its use in operating the Eastern Slope Regional Airport.

Agreeable to a petition signed by Lucinda Goslee and others.
Recommended by the Board of Selectmen.

John Hartman moved Article #14, Bob Graf seconded. Rick Young and Don Bacich both spoke in favor of the airport. There being no discussion, Article #14 was declared passed by hand vote.

ARTICLE #15

To see if the Town will vote to pass the following resolution: The Town of Eaton hereby requests the General Court of New Hampshire to propose or support an Amendment to the United States Constitution that empowers the Congress and the States to establish fair and comprehensive limits on campaign finance at all levels of government.

Agreeable to a petition signed by Kenneth McKenzie and others.

Ken McKenzie moved Article #15, Linda McKenzie seconded. Ken McKenzie explained that this resolution is an attempt to establish fair limits of financing by asking legislators to fix the problem. John Hartman stated that this type of funding is what pays

for the campaign advertising and noted that this resolution asks for a Constitutional amendment. Eugene Long questioned the proposed wording of that amendment. Ken McKenzie explained the process of adopting the amendment and noted that this is merely the place to start and that 57 Towns in New Hampshire have a similar Article on their Warrant. Robert Blaney spoke against and Bob Bridgham spoke in favor of this Article. ***There being no further discussion, Article #15 was declared passed by ballot vote (32 Yes/16 No).***

ARTICLE #16

To act on any other business that may legally come before this meeting.

Ralph Wilkewitz proposed the following: "It is hereby resolved that the Town of Eaton will not use any money from the town budget for the purchase of or application of any dust abatement material." Rick Young explained what dust abatement is and why it is used. Paul Hennigan explained that because this item was not on the Warrant and it could affect many people who are not in attendance, it is not appropriate to act on the request. Thaire Bryant stated that this issue should be addressed with the Selectmen during the year or petitioned for inclusion on next year's Warrant.

Ken McKenzie made a motion, seconded by Sunni Wilkewitz, to adjourn the Meeting. Motion passed by unanimous voice vote. Moderator Thaire Bryant adjourned the Eaton Town Meeting at 10:02 pm.
