C. RHINELANDER W 3	<p>City of Rhinelanders Question 1: Shall the City of Rhinelanders adopt the following resolution? Resolved that 'We the People' of the City of Rhinelanders, seek to reclaim democracy from the expansion of corporate personhood rights and the corrupting influence of unlimited political contributions and spending. We stand with communities across the country to support passage of an amendment to the United States Constitution stating: 1) Only Human Beings are endowed with constitutional rights – not corporations, unions, non-profits or other artificial entities, and 2) Money is not speech, and therefore limiting political contributions and spending is not equivalent to limiting speech. Question 2: Shall the City of Rhinelanders adopt the following resolution? Resolved that 'We the People' of the City of Rhinelanders, insist upon the creation of a nonpartisan procedure for the preparation of legislative and congressional redistricting plans, and, Further resolved that the process promotes more accountability and transparency and prohibits the consideration of voting patterns, party information, and incumbents' residence information or demographic information in drawing the maps, except as necessary to ensure minority participation as required by the U.S. Constitution.</p>
