# Minutes of the REGULAR MEETING Troy CITY COUNCIL March 1, 2012

The meeting was called to order at 7:00 PM by City Council President Kopka.

The roll call being called, the following answered to their names: Council members Kevin McGrath, Mark McGrath, Dean Bodnar, Bob Doherty, Ken Zalewski, Nina Nichols, Rodney Wiltshire, President Lynn Kopka.

Also present were Mayor Lou Rosamilia, Deputy Mayor Peter Ryan, Corporation Counsel Ian Silverman, Counsel to the Council Joe Liccardi

Harriet Graham led the Pledge of Allegiance.

City Council President Lynn Kopka delivered the Legislative response to the State of the City address.

## Others who spoke:

- 1. Patrick Jones of 60 Lori Jean Place in Lansingburgh spoke as a board member of his homeowners' association. He described problems with drainage and infrastructure and asked for support from the Council.
- 2. James Spear spoke regarding the McClusky property on Cemetery Avenue. He described the dangers of a property in disrepair and asked for the Council to take action to clean it up.
- 3. Eric Wisher, President of the Troy Firefighters spoke regarding the increased response time for Engine 3 because of the Campbell Avenue detour. He has met with the Mayor to discuss possible solutions to this public safety issue.
- 4. Jeff Piero of 52 Second Avenue spoke against the proposed change in the landlord registry and requesting a trimester check on property transfers. He spoke in favor of Resolution #4, as well.
- 5. Russell Ziemba of 1813 Highland Avenue spoke in favor of Resolutions 6 and 3. He urged caution in the administration of the measures in Resolution 5. He also urged the postponement of action on Ordinance 5 and for an independent assessment by a structural engineer.
