NOTICE IS HEREBY GIVEN, that at an election to be held in the County of Dunn, on November 4, 2014, the following proposed Resolutions of the Dunn County Board will be submitted to a vote of the people:

Question 1:

RESOLUTION NO. 54

DIRECTING THE COUNTY CLERK TO PLACE THE REFERENDUM QUESTION
CONTAINED IN THIS RESOLUTION ON THE NOVEMBER 2014 BALLOT
REGARDING EXPANSION OF MEDICAID/BADGERCARE

NOW, THEREFORE, BE IT RESOLVED that the Dunn County Board of Supervisors directs the county clerk to place the following referendum question,

“Shall the Governor and Legislature accept federal funding for the expansion of Medicaid/BadgerCare in Wisconsin to cover persons up to 133% of the federal poverty level to ensure that additional thousands of Wisconsin Citizens have access to quality and affordable health coverage?”

EXPLANATION

DIRECTING THE COUNTY CLERK TO PLACE THE REFERENDUM QUESTION CONTAINED IN THIS RESOLUTION ON THE NOVEMBER 2014 BALLOT REGARDING AMENDING THE CONSTITUTION OF THE UNITED STATES OF AMERICA.

NOW, THEREFORE, BE IT RESOLVED that the Dunn County Board of Supervisors directs the County Clerk to place the following referendum question,

“Shall the Constitution of the United States of America be amended to state that:

1. Only human beings, not corporations, unions, non-profits or similar associations, are endowed with constitutional rights, and;
2. Money is not speech, and therefore regulating political contributions and spending is not equivalent to limiting political speech.”

The question will appear on the ballot as follows:

“Shall the Constitution of the United States of America be amended to state that:

1. Only human beings, not corporations, unions, non-profits or similar associations, are endowed with constitutional rights, and;
2. Money is not speech, and therefore regulating political contributions and spending is not equivalent to limiting political speech.”

EXPLANATION

A “yes” vote means that you are in favor of instructing your state and federal elected representatives to initiate and support the process of amending the United States Constitution so that it only provides constitutional rights to individual human beings, and not to corporations, unions, non-profits, and other similar associations; and to allow for the regulation of political contributions and spending by corporations, unions, non-profits and similar associations because only human beings are endowed with constitutional rights.

A “no” vote means that you do not want your state and federal elected representatives to initiate or support amending the United States Constitution to provide that only individual human beings have constitutional rights and allowing for regulation of political contributions and spending by corporations and similar entities.
