Order of Questions/Issues in 2020: State, Municipal, Township, School and other Districts, County

Issue No.

Eastlake City (12 Pcts)

- 1 3 Mills Renewal Levy - Roads - 5 Years - Commencing 2021 tax year
- 2 Proposed Charter Amendment: Shall Section 2 of Article II be amended to replace the existing Section 2 of Article II and amend Section 2 of Article II to coordinate with the general laws of the State of Ohio regarding the nomination process for elected office and to provide for a primary election for elected office on the same dates as provided by for the general laws of the State of Ohio?
- 3 Proposed Charter Amendment: Shall Section 11 of Article V be amended to provide that City may provide notice of Council business on the City of Eastlake internet website or social media service?

Kirtland City (4 Pcts)

- 1 Proposed Charter Amendment: Shall the Charter of the City of Kirtland, Article VII - Charter Amendments, Section 2 - Charter Review Committee, be amended to give the mayor discretion to appoint a charter review committee more often than once every ten years?
- 2 Proposed Charter Amendment: Shall the Charter of the City of Kirtland, Article II-A - Appointed Administrative Officers and Departments, Section 2, 3, 4, and 5, be amended to eliminate Lake County residency requirements?
- 3 Proposed Charter Amendment: Shall the Charter of the City of Kirtland, Article VII - Initiative, Referendum and Recall, Section 5 - Mandatory Zoning Referendum be repealed to eliminate a mandatory zoning referendum and shall Article I - The Council, Section 8 - Powers and Duties, be amended to prohibit City Council from enacting any zoning amendment or change in the zoning map as an emergency measure?

Mentor City (35 Pcts)

- 1 Shall Ordinance No. 20-0-066 approving the construction of an ADA accessible boardwalk, observation deck, and observation tower at the Mentor Lagoons with the assistance of grant funding be approved?
- 2 Shall Article III, Section 3.09(A) of the Charter of Mentor be amended as follows:
 6. Legislation authorizing any of the following activities related to the Mentor Marina shall require voter approval:
 - a. The sale or lease of the Marina;
 - b. Any residential or industrial development; and
 - c. Any commercial development inconsistent with a marina.

The Mentor Marina consists of approximately 180 acres and includes all of permanent parcel numbers: 16-D-096-0-00-001-0, 16-D-096-0-00-004-0, 16-D-099-0-00-008-0, 16-D-099-0-00-011-0, 16-D-099-0-00-012-0, and 16-D-096-00-002-0.
 7. Legislation authorizing any of the following activities related to the Mentor Lagoons Nature Preserve shall require voter approval:
 - a. The sale or lease of the Nature Preserve;
 - b. Any development; and
 - c. Any activities inconsistent with the conservation of land, Nature Preserve activities, and the protection of ecologically sensitive areas and other areas with unique features.

The Mentor Lagoons Nature Preserve consists of approximately 280 acres and includes all of the land owned by the City of Mentor north of the Mentor Marina and extending to the Lake Erie shoreline, thence east to and including permanent parcel number 16-D-104-0-00-001-0.

- 3 Local Option (By Petition) - Shall the sale of wine and mixed beverages be permitted for sale on Sunday between the hours of ten a.m. and midnight by Riser Foods Company dba GetGo , an applicant for a D-6 permit authorizing the Sunday off premise sale of wine and mixed beverages who is engaged in the business of operating a convenience store at SW Corner of Kelly Drive & Center Street, Mentor, OH 44060 in this precinct?
- 4 Shall the sale of wine and mixed beverages and spirituous liquor be permitted for sale on Sunday between the hours of ten a.m. and midnight by Riser Foods Co., a holder of a D-6 liquor permit and a potential operator of state liquor agency store authorizing Sunday on/off premise sale of wine and mixed beverages and off premise spirituous liquor who is engaged in the business of operating a grocery store at 8383 Tyler Blvd., Mentor, OH 44060 in this precinct?
