General Board Meeting Minutes

I. Call to Order and Roll Call

SORO NC Board President Doug Fitzsimmons called the meeting to order at 7:10.

II. General Public Comment

Raymond Yu spoke about Nisei Week Japanese Festival (August 13-21, 2011) and the Nisei Grand Parade on Sunday, August 14 at 5:30pm in Little Tokyo. More info at niseiweek.org.

Beth Ryan reported on the Stepping Forward program, just completing its fourth week. Career Week begins with two sessions (2-3pm and 4-5pm) on August 2. Volunteers should email Beth.

III. Community Briefing

Sarah Shaw of JMB Realty presented early outlines of the proposed Century City Center project, now modified from a largely residential development to office space. The project will have 40% less square footage (7000 sqft), and be a mix of traditional office space with open business incubator areas. Goal is LEED Platinum certification.

The Draft EIR will be completed in Winter 2011-12, and a final EIR in Spring 2012. Project opening will be in late 2014. JMB pledged to have an open, inclusive process and will involve the NC throughout.

With the project's re-conception, JMB is working with the DOT to expand their traffic study. Eastern boundary not yet set (likely east of Robertson), but they will notify the NC when it is. Southern boundary will be south of the 10 Freeway.

Board and public concerns largely revolved around traffic impact to Motor, Robertson and Pico, as well as need for increased Fire Station coverage, given recent reductions by LAFD.

IV. Old Business

Confirmation of Board committee memberships and absences (GB072111-1) Nahed Guirguis requested an official absence for July and August 2011. Troy Richardson joins Outreach; Sam Jagger joins Land Use.

LAPD. SLO Gonzalez reported that there had been no major incidents or increases in crime over the last month.

Office of Councilmember Wesson. Liz Carlin reported that 800 people had attended the Movie in the Park at Reynier and thanked the NC for its support. Helms Bakery complex is also holding outdoor movie nights (info at helmsbakerydistrict.com).

Fresh & Easy is proposing a mini-store on La Cienega. P.I.C.O. NC PLUM committee will be addressing it at a future meeting. The proposed In & Out on La Cienega failed to secure the necessary properties.

Office of Councilmember Koretz. No report

Office of the Mayor. Joseph Hari spoke about the upcoming Town Hall with Mayor Villaragosa on Monday, Sept. 12 at the West LA Municipal Building. Time is not yet set, but it will probably be in the evening.

He would also like to meet with groups from the NC to better understand our priorities and concerns. He will also have reps at the August 2 BONC hearing and will follow up on potholes that were reported, but not filled.

VI. Committee Reports

Executive. Gerald Chavarría has regrettably resigned from the Board, and the Secretary position is therefore currently open.

LVNOC reps for Robertson Rec redevelopment will be Brian Kite and Doug Fitzsimmons, and committee meetings will begin soon.

Mary Beth Fielder and Daniel Lee provided background on the issue.

Motion for a non-binding resolution supporting an amendment to the U.S. Constitution to deny personhood and its rights to corporations (Levine / GB072111-3)

- Michael moved to table the motion until August to provide time to solicit opposing viewpoints; Terry seconded.
- Table vote: 6-Y, 10-N, 0-A. Motion to table failed.

Proposed amendment by Michael:

"The South Robertson Neighborhoods Council recommends a non-binding resolution to support an amendment to the United States Constitution that would deny personhood and its rights to corporations, as well as stating money is not equal to free speech."

- Michael moved to consider the amendment; no second.
- Amendment not considered.
- Marj calls the question; Barry seconded.
- Call the question vote: 7-Y, 9-N, 0-A. Discussion continues.
- Barry moved to consider the motion; Marj seconded.
- Motion vote: 10-Y, 6-N, 0-A. Motion approved.

Motion to send letters to elected officials expressing our support for the constitutional amendment (Levine / GB072111-4)

- Robyn to consider the motion; Kimber seconded.
- Vote: 10-Y, 6-N, 0-A. Motion approved.

Motion to approve a \$3000 Neighborhood Purpose Grant for 2011 Peace Picnic (Bock / GB072111-5)

- Kimber calls the question; Barry seconded.
- Call the question vote: 16-Y, 0-N, 0-A. Discussion ends.
- Robyn moved to consider the motion; Marj seconded.
 - Motion vote: 0-Y, 13-N, 3-A. Motion fails.

Motion to hire a monthly note-taker (Gomes / GB072111-6)

Motion withdrawn

Vote to elect new SORO NC Secretary (GB072111-7)

Doug updated the Board on the disposition of the July 5th BONC hearing and presented potential compromise options.

Motion amended without objection to add:

"f. That SORO NC would consider adopting the east side of La Cienega only, with Mid-City NC adopting the unrepresented residential areas."

Motion divided into six parts without objection: items 9a, 9b, 9c, 9d, 9e, 9f.

Harold moved to consider motions 9a-f; Bette seconded.
